- Update on information on a generator for the EE Hall It is not feasible to purchase a
 generator to run the Eddie Eastman Hall unless we have a grant to purchase as it would
 be a very expensive project. So, we will defer at this time.
- Update on internet connection for the Fire Hall To have a new internet service hooked up it will cost around \$100.00 per month. Angela to email the fire department to see if this is something they would like us to explore. A booster will be hard to boost from the office to the fire department. Maybe an ethernet cable from the town office will work. Angela to request a bell technician to come out and give us our options. Also, if we went with Starlink they have 50% off installation right now.
- Asset inventory update The fire department gave us their list of assets and now we need to update the rest of the Town's inventory.
- Compost bins It looked good for us to order 40 bins in which we would have 20 and the Town of Traytown to have 20 if the project went ahead as it was just a exploratory option to see how much interest MMSB would receive on this but when asked the question of having two separate drops in both places MMSB said they couldn't do that so the Town of Traytown would have to figure out how to transport their 20 bins from here so it wasn't feasible for them to have this extra cost so we didn't try for this as the total minimum order of 40 would have been to many for us. We will continue to watch for more opportunities in this area.

Recreation Committee update – On March 1, 2023, we had our first meeting at the
Eddie Eastman Hall. In attendance was Geoff Moore, Julie Pike, and Linda HillierSmith from Council and Shirley Barrington, and Bunny Greening. Beaudette Simard
and Donna King are members but was unable to attend. A group chat was set up and

Linda Hillier-Smith took the minutes but in the future it will be taken by Shirley Barrington or Bunny Greening. They had the first event – a card event on March 7, 2023 at the Eddie Eastman Hall and there were 14 people there and the Mayor dropped in. There was a 50/50 draw which totaled \$77.00, and the winner was Shirley Barrington. Bingo will go ahead as soon we get our licence as we are all set up for it just waiting on the licence.

• Grants – We received a quote from Home Hardware in Glovertown on the supplies and labor needed for the main entrance to the town office and it was included with the Building Age-Friendly Communities Grant that is applied for. The swimming pond area project will be starting this spring with a purchase of a mobi-mat, mobi-chair, and mobi-deck in which will take up to three weeks to get here at a cost of \$13,153.00 cdn. Also, there will be a new wheelchair accessible outhouse/change room and a clean up of the area and extension for more parking. We will be getting a quote from three contractors in the spring on the work that needs to be done.

Ralph Calloway Memorial Park, Park Liaison, Crown Lands - Mayor Granberg

- Park fee arrears update one paying by end of week so it will not go to collections. One small payment from the collection company for one account.
- Upgrades to the trailer park We are looking at using orange rope to rope off sites that are in arrears when the town worker works on putting posts on back and front of sites and the next step after the sites are roped off and accounts are still in arrears is the removal of the trailers from the park. This year we will have tags to go in windows showing fees are paid for 2023 season. Mayor Granberg will price out a laminate machine and get it ordered as it was budgeted for so we can laminate these tags. We had a get together of Council today and discussed the options for sewer disposal and we agreed on a dumping station tank and we also discussed ways of getting water for the park. The town worker would check on tank and the tank area to monitor when it would need to be dumped.

 completed. Mayor Granberg and Angela have a meeting on Thursday at 4:00pm to go
 over more crown lands applications.
