Public Works, Communication, Grants update - Deputy Mayor Pike

- Update on work being completed on route 301 We are collaborating with John Baird on this matter. We know that to date J1 Contracting has amended their application to Quarry Referrals to remove the asphalt plant from the application but there are still issues with the application that need to be addressed and to date there is still no development permit requested for the work being done to reroute 301 or plans to change the Town Plan. Council met with John Baird today and it was very informative. He is working on a response to be sent to J1 Contracting, TI, and Quarry Referrals and hoping to have completed by the end of this week or the beginning of next week. There may be additional charges, but it is a matter that must be resolved.
- Shingles on the Eddie Eastman Hall update Angela spoke with the contractor, and
 he said that area where we noticed the shingles were lifted is in fact a board that is
 raised up in the roof. To fix this board the shingles would have to come up and we

- cannot get the same shingles as there now. The contractor is going to check on what other options there are to complete the repair, but he said that this board being raised would not cause a leak. He will be up in the next couple of weeks and give us our options and look at the pipes in the attic at that time.
- Grants update We have received the grant for our community garden in the amount of \$1,339.00 from Active NL. This project will be starting soon when our town worker is back for the season. There is another grant in the final stages of being received in which we will announce when ready to go. We have applied for a chance to win a \$10,000.00 grant from Take Charge NL for a heat pump system at our Municipal building area. Our Active NL grant application for two new pieces of playground equipment for the Ralph Calloway Memorial Park has been transferred to the 2024-2025 grant in which the deadline to apply is in September 2024. Hopefully, we will be successful the next time in this grant. We have heard by phone that we are successful in receiving a grant for a summer student under the Canada Summer Jobs and we are now waiting on an email with further instructions.

Ralph Calloway Memorial Park, Park Liaison, Crown Lands - Mayor Granberg

- Update on prep planning for second stage with septic in RCM Park We sent out the scope
 of work to six well drilling companies for bids. The bid closed today at 2:00PM and no bids
 came in. Angela will reach out to the companies again to see if they would give us a quote
 on the job and when they could possibly do the work. The town worker can go ahead and
 build a pump house and a privy.
- Announce if not returning for season let office know by May 1st For the seasonal campers
 at the Ralph Calloway Memorial Park, they must notify the office by May 1, 2024 if they are
 not returning for the season and have their campers out of the site by May 1, 2024 weather
 permitting if not they will be charged for any days after up until notification is received by
 the town office.

- Crown lands update We have received Minister approval on seven of the applications sent
 in. They said they are still reviewing the other ones and waiting on more information on
 them to approve. We received notification that two more application are gone for final
 review with Crown Lands. This week we received letters on two applications that are in the
 final stages and waiting for Minister approval if not received by one month from the date of
 the letters the applications will be cancelled so Angela reach out to the Minister's office and
 they are contacting Crown Lands to make sure that these applications does not get cancelled
 until the Minister gives a response to us and Crown Lands.
- Pine Tree Lots –WIP. Council members will have a walk of the land there and see, if
 possible, to have the survey changed so the original four lots that Council wanted can
 actually go there. What was intended and what was surveyed is two different shapes. Angela
 will reach out to the surveyor on the matter to see why the land was surveyed in that shape
 because it only allows for two lots this way. Maybe if the surveyor is in the area in the next
 while they could possibly have a chat with Council on our options.

Social, Student Employment, Municipal Affairs, Public Relations, Beautification

- Municipal Affairs update The 2024 symposium is going ahead in Gander on May 2-4, 2024, and Mayor Granberg, and Angela will be attending this year. It is a great time and place to ask questions on topic concerning our town. If Council has anything you would like us to bring forward, please let the office know.
- Public Relations Our Town worker will be returning to work on April 29, 2024, for the season. The Community Leaders Forum for this year is set for April 23, 2024, and Mayor Granberg went last year and is going to attend on behalf of Council again this year. If there is anything the town would like to see if Terra Nova National Park would like to donate to the town i.e.: picnic tables or used CSA approved playground equipment they may have and not using anymore, please let the office know so it can be asked about at the meeting. Last year Mayor Granberg asked about the no gas sign that the town had asked the park about prior, and it was shortly after that it did get installed. We have heard from a few residents in town that they are so impressed with the new pieces of playground equipment in the playground. This is nice to hear and to know that the kids are using it. We received an email a while ago on someone wanting to film a couple of scenes here in Terra Nova for their film. Angela will reach out to them to let them know that Council is okay with this.
- Beautification update The Town worker will start cleaning up of town, set up the doggy poop stations, and place the garbage cans back out around town when he gets back to work. The tulips that were planted last year are starting to grow. The community sign board is back up and running for the season. This sign board is great up until first frost then the letters will not stick to the board and just blow off. We received an email a while back in regards to the placement of a memorial bench in town and it was suggested by them to place in the main playground but with everything in the area there Council asked Angela to reach out to them to suggest in the River Road area just up from the Ralph Calloway Memorial Park where the birch tree are because a lot of people stop there and have a picnic or just to enjoy the view in that area and there is always a garbage can in that area as well or maybe by the trussell area but there is already one bench there now.

New Business:

- Background on old typewriter I received a call on March 21, 2024, from Arlene
 Greening and she just wanted to give some history on the old typewriter here on display
 at the Town office. She said that she had bought it 36 years ago and her father, Don
 Greening, used to use it at his home to type up everything for Council as he was on
 Council back then. When Council started to work out of the Eddie Eastman Hall, she
 figures it was brought there to use. Just a little background information. Everyone is
 loving all the items on display at the town office and all the history that goes along with
 the items.
- Rental in July of the Eddie Eastman Hall The person the hall has been named after is renting the hall in July and it would be nice to see the rental fee waive for this person.

were charged to an Airbnb in which they have two Airbnb's but both under the one
owner/operator and last year they were only charged for one business tax but this year
they were charged two business taxes for the one business. They live in which ever one is
not rented out as per the owners.

Town of Terra Nova

- 1. NO LIVESTOCK PERMITTED ON LAND INDICATED AND ISSUED FOR RESIDENTIAL USE AS INDICATED ON THE MUNICIPAL TOWN PLAN 2019-2029. WITH THE FOLLOWING EXCEPTIONS:
 - A) SMALL ANIMALS / POULTRY FARMING CAN BE APPROVED AT COUNCIL'S DISCRETION, SUBJECT TO LIMITATION ON THE NUMBER OF AMINALS AND THE LOCATION OF THE LIVESTOCK FACILITY ON THE LOT. EXAMPLE: RABBITS, DUCKS, CHICKENS, TURKEYS AND GEESE
- SMALL AMINALS / POULTRY FARMING, WILL BE SUBJECT TO THE FOLLOWING:
 - A) NO SMALL ANIMALS / POULTRY WILL BE PERMITTED ON LOTS LESS THAN 0.4 HECTARES IN SIZE
 - B) THE PERMITTED QUANTITY OF SMALL ANIMALS / POULTRY ON A LOT AND THE MINIMUM SETBACK OF A SMALL ANIMAL / POULTRY FACILITY WILL BE IN ACCORDANCE WITH THE FOLLOWING TABLE:

DOG REGULATIONS

By-Law Number 2 2007

Whereas there is a problem associated with dogs running loose within Town of Terra Nova boundaries, which causes a danger to the residents and visitors.

Whereas present municipal law exists that prohibits dogs from running free within a community,

Be it resolved that – The Town of Terra Nova hereby enacts a regulation that supports the Municipalities Act 1999 – Chapter 24 Section 414(2)

A council may make regulations:

(g) Prohibiting, restricting and controlling the running at large if dogs and other animals and restricting and controlling the keeping of dogs and other animals:

(H) Providing for the seizure and impounding of animals found at

large or kept contrary to regulation;

(I) Prescribing fees for the impounding of dogs and other animals: (J) Providing for the sale, seizure, destruction, and disposal of diseased and impounded dogs and other animals not claimed and for which a fee is not paid in the time established by regulations.

Pursuant to the powers vested in it under and by virtue of Section 414(2) of the Municipalities Act of the Terra Nova Town Council in a regular session convened on this 3rd day of August A.D. 2007 hereby passes and enacts the preceding Regulations relating to the handling of dogs in the Town of Terra Nova

Update on the Municipal Assessment Agency

The Board of Directors for the Municipal Assessment Agency (MAA) held its first meeting of the year virtually on March 8, 2024. Committee meetings were held the previous day.

Some of the issues addressed by the Board included:

- Human Resources was examined in terms of recruitment and retention tactics, workplace health and safety, and labor relations.
- MAA developed an Accessibility Plan for 2024 to 2026, as mandated by the provincial government. The Accessibility Act requires that all government departments, agencies, commissions, and boards develop and implement a three-year accessibility plan, which will ensure compliance to the Act. MAA's Accessibility Plan can be viewed on the Agency's website.
- Aerial imagery reviews are now complete for the municipalities of Avondale, Clarke's Beach, and Upper Island Cove.
- An agreement was signed with the Town of Conception Harbour and work has commenced in that municipality to produce an assessment roll for Tax Year 2025.
- MAA welcomed the Town of Hawke's Bay as its newest client. Preliminary work has begun for Tax Year 2025.
- The Agency's CEO presented at MNL's Avalon/Eastern regional meeting in Clarenville on March 1 and is scheduled to speak at the Central meeting in Grand Falls-Windsor on March 22. Additionally, MAA will take part in the Northern/Western and Labrador meetings set for September of 2024.
- The Board reviewed the Agency's financial statements and accounts receivable report at the end of the third quarter (December 31, 2023).



- The Agency is a Gold sponsor for this year's Professional Municipal Administrators (PMA) annual Convention and Trade Show, scheduled in Gander from April 9-11. The CEO will present on behalf of the Agency. In addition to promoting the Agency's services and objectives, MAA is hosting a pre-conference workshop on April 9 from 9:00 am to 12:00 pm to provide municipal representatives with practical training and information regarding the relationship between property assessment and municipal taxation. There is no charge for MAA's workshop, but registration is required through the PMA website.
- May 2-4 in Gander is the date of the annual Municipalities Newfoundland and Labrador (MNL) Municipal Symposium. The CEO will speak on behalf of the Agency who is a gold sponsor of the event.
- The 2024-2025 meeting schedule was reviewed and adopted.
- A preliminary educational video was presented to the Board. The video will be made public and hosted on the Agency's website.
- The Board of Directors congratulates Mayor Tony Keats of Dover on winning the 2023 World Mayor Community Award. Mayor Keats, Central Director on the Agency's Board of Directors, received this award for his extraordinary service to his town and its people since 1996.
- The next Board meeting is scheduled June 6-7, 2024, in Gander.

Municipalities who are considering new projects that support property assessment and valuation services (including GIS or imagery projects) are encouraged to contact the Agency to see if the project qualifies for funding under our Collaborative Initiative Fund.
