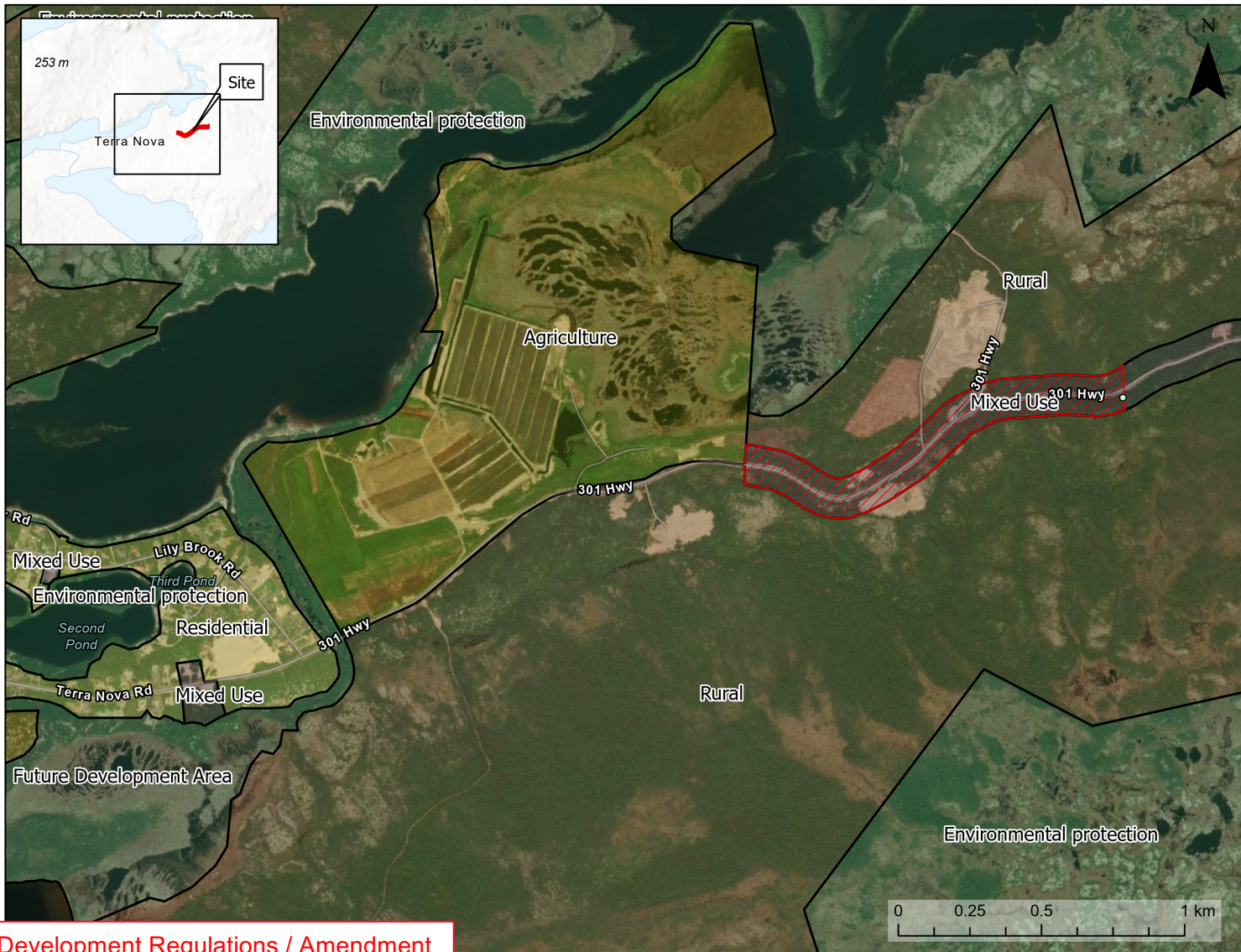
The amendment rezones approximately 18 hectares of land adjacent to Terra Nova Road (Route 301) from Mixed Use to Rural.
