DETAILS OF SCOPE OF WORK:

- MAKE LARGER HOLE IN TANK FOR PROPER DISPOSAL OF CONTENTS
- ENGAGE A PUMPER TRUCK TO PROPERLY REMOVE CONTENTS FROM THE APPROX. 2100 GALLON TANK
- DIG UP AND DISPOSE OF TANK APPROX. SIZE IS 17.5 FEET BY 5 FEET WIDE.
- FILL IN WITH THE SOIL THAT WAS REMOVED IN THE AREA PLUS PIT RUN OR EQUIVALENT AND LEVEL GROUND IN THIS AREA

NOTES: THIS LARGE TANK WAS PUT IN THE GROUND MANY YEARS AGO FOR A SEPTIC TANK BUT WAS NEVER USED BY THE TOWN AS A SEPTIC TANK. IT IS VERY CLOSE TO THE SURFACE OF THE GROUND IN THIS AREA. IT IS APPROX. 2100 GALLONS AND THE APPROX. SIZE IS 17.5 FEET LONG BY 5 FEET IN DIAMETER AND THEREBY CYLINDER SHAPED. IT IS LOCATED IN THE MARKED AREA AT THE RALPH CALLOWAY MEMORIAL PARK ON SITE 7 AND SITE 8.
