DIG A TRENCH LINE AT THE RALPH CALLOWAY MEMORIAL PARK FROM THE WATER WELL TO THE NEW PUMPHOUSE LOCATION THAT WILL BE APPROXIMATELY 60 FEET LONG BY 3 FEET WIDE AND 4 FEET DEEP. WHEN ALL ELECTRIACAL AND WATER LINE IS PLACED IN THE TRENCH IT IS TO BE BACKFILLED THE SAME DAY AS DUG. ACTUAL DATE WILL BE DETERMINED IN COMMUNICATION WITH THE COMPANY THAT WILL BE INSTALLING THE ELECTRICAL AND WATER LINE IN THE TRENCH.
